Over 20 million people participated that year.

Earth Day is now celebrated in more than 175 countries every year. Numerous communities celebrate Earth Week with an entire week of activities focusing on environmental issues. In 2009, the United Nations designated April 22nd as *International Mother Earth Day*.

Since the first Earth Day was celebrated, the efforts of dedicated elected officials and involved citizens have produced the passing of legislation such as the Clean Air Act, Toxic Substances Control Act and Clear Skies regulations, which have made the world we live in a much healthier place for everyone.
