The Parent-Child Home Program was created nationally in the 1960s by Dr. Phyllis Levenstein with the understanding that the best way to prevent children from dropping out of school was to foster a love of learning at home from an early age. Her method emphasized reading and verbal interaction.

The Miami Beach Parent-Child Home Program serves residents through an innovative home-based program that emphasizes early childhood literacy and solid parenting skills. The voluntary program is designed to cultivate a strong parent-child relationship, improve language and literacy skills as well as encourage social and emotional development. Key elements of the program include highlighting the role of the parent as a child's first teacher, and respecting privacy and cultures.

The program participants must be Miami Beach residents who currently meet a low income threshold. Children from 16 months old to younger than 3 years qualify as do parents or children who are born in another country and have not obtained college degrees. As part of the program, trained home visitors meet with families 2 times a week to foster verbal interaction and learning through play. Families are supplied with appropriate books and toys to reinforce their teachings.
