The purpose of this bid is to establish a list of pre-qualified vendors, to furnish all labor, supervision, equipment and materials necessary, for the purchase of marching band uniforms, for various Miami-Dade County public schools. These vendors will be contacted to submit competitive quotations for specific scopes of work on all jobs exceeding the \$1,000 threshold. This is a term bid which states that the Board may purchase quantities, as may be required, but is not obligated to purchase any guaranteed amount. Four (4) vendors responded to this advertised solicitation.

The term of the bid shall be for two (2) years from the date of award and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the awardee(s), be extended for one (1) additional two (2) year period and, if needed, ninety (90) days beyond the expiration date of the current contract period.

Strategies were employed to increase M/WBE participation, inasmuch as the list of registered vendors with the District does not reflect certified minority firms for this category.
