Housed on their 120-acre Coral Gables estate, it included the largest private collections of palms and cycads in the world. Today, the MBC is an independent, nonprofit institution devoted to advancing the science, education and conservation of tropical botany.

The MBC carries out its mission by collecting seeds from wild populations of palms and cycads from around the world. The seeds are germinated in the MBC's nursery and grown in population-based, documented, scientific collections in its extensive garden. MBC fosters and participates in scientific research by collecting and maintaining scientific data on its collections and sharing data to scientists for research purposes.

The MBC's unique scientific and conservation collections are dynamic, continually being developed, and also have great educational value. A wide range of educational opportunities is found at MBC for students from elementary school through the postgraduate level. A 24-hour-a-day, living laboratory and classroom, MBC has hosted Miami-Dade County Public Schools students, teachers, and classes interested in scientific plant collections. Several Miami-Dade public schools have participated in Environmental Immersion Day hosted by the MBC as part of The Fairchild Challenge environmental education program.

The Montgomery Botanical Center is to be commended for its dedication to preserving the environment as well as for advancing research, conservation and education through scientific plant collections.
