In 2010, the State of Florida enacted Academic Achievement Scholarship Signing Day by declaring the third Tuesday in April each year as "Academic Scholarship Signing Day." Section 1001.43 (14), Florida Statutes (F.S.) encourages school districts to recognize the importance of motivating students to attain academic achievement by promoting public recognition of seniors who sign a letter of intent to accept an academic scholarship. The Florida Statute encourages school districts to bestow the same level of recognition to its academic scholars as it does to its athletic scholars. On July 14, 2010, the Miami-Dade County School Board unanimously approved a board item supporting and encouraging the commitment of outstanding student scholars. High school seniors who sign a letter of intent to accept an academic scholarship offered to the student by a postsecondary educational institution shall be recognized for their outstanding academic achievement.

School counselors and College Assistance Program (CAP) advisors are uniquely positioned as the school professionals best able to take the lead in establishing a college-going culture and guiding students towards college readiness. They provide students planning, preparation, participation, and performance in a rigorous academic program that connects to their college and career aspirations. School counselors and CAP advisors give students and families clear guidance, strong support, and vital information and resources to reach their college and career goals.

The Miami-Dade County Public Schools Division of Student Services provides support and direction to schools and community organizations in conducting activities, including assemblies or other appropriate public events, in which students offered academic scholarships assemble and sign actual or ceremonial documents accepting those scholarships. These activities make academic success and recognition visible to students, parents, and community members. Miami-Dade County Public Schools commends student academic scholars for their dedication and commitment to academic excellence.
