The Village of Pinecrest has a rich reputation as a community dedicated to public service and community engagement. It recently earned the coveted designation as a Community of Respect by the Anti-Defamation League (ADL). The ADL created the Community of Respect Initiative to allow municipalities, organizations, houses of worship and businesses to be honored for their efforts to promote diversity and respect through adopting a local school to become a No Place for Hate school. As a Community of Respect, Pinecrest will adopt and sign the Resolution of Respect and receive a banner.

The Village of Pinecrest has the distinction of being the first community in the state to have all of its schools participate in the No Place for Hate program. No Place for Hate schools sign a Resolution of Respect and participate in anti-bias activities that promote equality, understanding and acceptance regardless of race, language, color or culture. Pinecrest's No Place for Hate Schools include Miami Palmetto Senior High, Palmetto Middle, Howard Drive Elementary, Pinecrest Elementary and Palmetto Elementary schools.

In addition, the ADL promotes its National Youth Leadership Mission (NYLM) through its Kindness Tour. Each year, a group of student delegates participate in a three-day program in the nation's capital, which examines the effects of discrimination and hatred. Activities include a visit to the United States Holocaust Memorial Museum. The delegates then return home to share the message of kindness and hope with their school mates and community. Pinecrest-area students joined together to initiate and kick off a Kindness Tour, which will be carried out next school year. These participants created 'Kindness Boards' in their schools which involved students carrying out Acts of Kindness in the schools for a week-long period as a kick-off event. } Revised
