The financial statements of WLRN Television and Radio Stations were audited by Rodriguez, Trueba & Company, P.A. Certified financial statements are required by the Public Telecommunications Financing Act of 1978 and are used as the basis for determining the Corporation for Public Broadcasting grants to the stations, which in 2012-13 were approximately \$2 million. The auditors concluded that the financial statements present fairly in all material respects the financial position of the Television and Radio Stations. No material findings were reported.

Total revenues for the Television Station was \$7.4 million which represents a decrease of \$2 million from the prior year. Total revenues for the Radio Station was \$8 million. which also represents a decrease of \$2 million from the prior year.

The School Board Audit and Budget Advisory Committee reviewed these financial statements at its December 3, 2013, meeting and recommended transmitting them to the School Board.
