He began his career with the school district as a music teacher at Marjorie Stoneman Douglas Elementary School. Under the leadership of his mentor Dr. Manuel C. Barreiro, he blossomed as a teacher as well as a working with vocal and instrumental ensembles. During his tenure with the school district, he successfully led his ensembles in competition and created major productions and fundraising concerts.

His time as an educator prepared him for the leap into the music world where he has a strong reputation as a musical powerhouse with the magic touch when it comes to a wide array of Latin music including salsa, rock, merengue, hip-hop, bachata and reggaeton. Mr. Rosado has worked with a legendary cast of artists such as Ricky Martin, Marc Anthony, Selena and Olga Tañón. He has led musical workshops and clinics around the world.

His most recent accomplishment was winning the 2013 Grammy Award for Best Tropical Latin album of the Year. The Puerto-Rican native co-wrote Alejandro Guzman's song *Lipstick*, which was nominated for a Grammy and Latin Grammy as Best Latin Rock Album of the Year. He also penned Yolandita Monge's *Sentimiento Boriqueño* as a love letter to his beloved Puerto Rico.
