During the Florida 2014 Legislative Session, the Miami-Dade County Legislative Delegation's support for Miami-Dade County Public Schools' (M-DCPS) 2014 legislative priorities was unwavering. The Miami-Dade County Legislative Delegation helped to secure fair and equitable funding for M-DCPS. The Legislature boosted education funding by \$574 million, an increase of 3.14 percent statewide. The Base Student Allocation increased by \$279.47 per student statewide.

The key issues passed in support of M-DCPS and/or K-12 public education include:

- Increased M-DCPS' potential funding by \$78.3 million or 3.29 percent, which is higher than the statewide average of 3.14 percent;
- Increased M-DCPS' per student spending by \$185 or 2.72 percent, which also exceeds that of the statewide average;
- Established a prior funding millage adjustment of an amount equal to 75 percent of the District's most recent unrealized Required Local Effort ensuring Miami-Dade students receive their fair share of education funding (Value Adjustment Board);
- · Increased funding for New World School of the Arts;
- Increased enrollment work load by \$54.5 million;
- Increased high school and middle school industry certification funding by \$30 million;
- Allocated \$40 million for digital classrooms;
- Allocated \$10 million for dual enrollment instructional materials and clarified that school districts are not responsible for paying the post-secondary institution tuition costs when the dual enrollment is taken during the summer months;
- Granted in-state tuition for undocumented immigrants who attended and graduated from a Florida high school;
- Appropriated \$50 million for Public Education Capital Outlay for public school renovation, repair, and maintenance;

- Opposed any mandatory diversion of Local Discretionary Capital Outlay levy revenue from traditional public schools to non-traditional public schools;
- Maintained local school board authority regarding the disposition of local capital outlay funds and impact fees;
- Provided equitable and appropriate assessments for students in special education and those students classified as English Language Learners;
- Convened the legislative session in January to allow adequate time for budget development and new legislative initiatives;
- Rejected increases in caps and maintained uniformity among local and state government agencies;
- Maintained the dual education delivery system that allows local school districts and local community colleges to offer adult programs; and
- Provided state funding for any increased costs to the employer's contribution to the Florida Retirement System.

With continued financial challenges facing public schools, the Miami-Dade County Legislative Delegation made education a priority and supported legislation that benefited M-DCPS and the hundreds of thousands of children it serves.

WHEREAS, during the Florida 2014 Legislative Session, the Miami-Dade County Legislative Delegation's support for Miami-Dade County Public Schools' (M-DCPS) 2014 legislative priorities was unwavering; and
