The purpose of this bid is to purchase, at firm unit prices, food-service paper products, and preapprove a list of eligible vendors to quote additional items under these categories, for various district departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Twenty-three (23) vendors responded to this advertised bid. This is an award to primary and alternate vendors.

The term of the bid shall be for one (1) year from date of award and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the awardees, be extended for one (1) additional one (1) year period and, if needed, ninety (90) days beyond the expiration date of the current contract period.

Items 7, 14, 16, 30, 40, 47, 51, 66, primary for Items 39, 45, 46, 48, 49, 50, 52, 57 through 61, and alternates for Items 3, 15, 19, 25, 35, 37, 38, 41, 47 through 50, 53 and 62 are being held for evaluation and will be awarded at a future Board meeting.

No bids were received for Items 17, 26, 27, 33, 43 and 70. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Policy 6320, Bidding Process – Competitive Bidding Requirements, which describes the procedure and guidelines to be used for bidding on the estimated dollar expenditure.
