Introduction

The Board previously approved an initiative through which a school site located in Downtown Doral was conveyed to the Board in lieu-of-impact fees for construction of a charter elementary school; a number of agreements were executed to implement this initiative and in July of 2013 the Board commissioned a project architect. The project has been bid competitively and the present item provides a recommendation for a bid award to the lowest responsive, responsible bidder. The entire project is funded and financed through the charter school entity and no District funds are being used for design or construction. Consequently, the bid solicitation included a non-mandatory aspirational SBE level of 10% and a non-mandatory 10% aspirational local workforce participation level pooled countywide. The recommended contractor may, subsequent to Board award submit a list of SBE subcontractors.

Additional Information

Eleven (11) pre-qualified contractors picked up a CD Disk or a hard set of prints and specifications. Advertised bids received and opened on July 15, 2014 by The School Board of Miami-Dade County, Florida were tabulated and analyzed, see Attachment A. The Alternates on this project were as follows:

Alternate No. 1 – Tile Wainscot at Restrooms

Alternate No. 2 – Lightweight Insulating Concrete Roof Insulation

Alternate No. 3 – Kitchen Equipment

Alternate No. 4 – Window Treatment

Alternate No. 5 - Empty Electrical Conduit

Alternate No. 6 - Marquee Electronic Sign

Alternate No. 7 - Tile Wainscot at Corridor and Extended Learning Areas

The Base Bid of the low responsive bidder is \$7,734,800, which is 15.5% under the budget. The charter school entity has requested inclusion of Alternates # 1, 3, 4, 5, 6,

which brings the low bid to \$7,815,306, 14.7% under the budget. The Project Architect's final construction cost estimate for this project was \$9,163,033 and the construction budget is \$9,162,000.

Description

The Scope of Work under this project consists of construction of an approximate 850-student station elementary charter school, along with all required on and off-site improvements, as provided for in the project plans and specifications.
