It was founded by a Taiwanese monk, Buddhist Master Hui-Li, after discovering babies abandoned and left in garbage cans and witnessing hundreds of orphans dying of diseases and neglect during a visit to Africa in 1992. ACC opened its first center in Malawi on October 2005 with room to house 600 orphans.

ACC under the supervision of Master Hui-Li and with the support of the Chinese/Taiwanese communities has provided children with a safe living environment, one where they can be nursed back to health, as well as, providing them with opportunities to receive a proper education including lessons about the Chinese culture, fine arts and martial arts. Since 2007 ACC showcases the children's cultural talents by taking them on Goodwill Missions all over the world. This year 12 children and eight chaperones led by Master Hui-Li are spending two months performing in 11 major cities in North America, including Miami. Performances range from singing and dancing to martial arts demonstrations.

The goal of ACC is to raise orphans with a healthy mental, physical and spiritual disposition. Today the care center serves over 6,000 children and provides similar programs in six other countries. ACC's model is based on a "Big Family" or "Children's Village" idea. Twelve families form a village where each family consists of a group of 16-20 orphan children, a nanny, and two adults that provide the roles of mom and teacher. The families get to interact with one another thus allowing all of the children to experience a full life of positive interactions.

The School Board commends Master Hui-Li and the Amitofo Care Center for its humanitarian efforts in providing orphan children the opportunity to enjoy health, freedom from starvation, disease, and an untimely death, a family-like experience and a proper education in order to become contributing members of the global family.

The families interact with one another thus allowing all of the children to experience a full life of positive interactions; and

WHEREAS, The School Board commends Master Hui-Li and the Amitofo Care Center for its humanitarian efforts in providing orphan children the opportunity to enjoy health, freedom from starvation, disease, and an untimely death, a family-like experience and a proper education in order to become contributing members of the global family.
