RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- expel the student specified in supplemental material SM-6 furnished under separate cover to School Board members, from the regular and adult programs of Miami-Dade County Public Schools and assign to alternative school/programs for the maximum time permitted under law, which is the 2014-2015 school year, the 2015 summer session, and the 2015-2016 school year;
- expel the student specified in supplemental material SM-7 furnished under separate cover to School Board members, from the regular and adult programs of Miami-Dade County Public Schools and assign to alternative school/programs for the maximum time permitted under law, which is the 2014-2015 school year, the 2015 summer session, and the 2015-2016 school year;
- expel the student specified in supplemental material SM-8 furnished under separate cover to School Board members, from the regular and adult programs of Miami-Dade County Public Schools and assign to alternative school/programs for the maximum time permitted under law, which is the 2014-2015 school year, the 2015 summer session, and the 2015-2016 school year;
- 4. expel the student specified in supplemental material SM-9 furnished under separate cover to School Board members, from the regular and adult programs of Miami-Dade County Public Schools and assign to alternative school/programs for the maximum time permitted under law, which is the 2014-2015 school year, the 2015 summer session, and the 2015-2016 school year;
- 5. provide educational services in alternative school/programs during the term of the expulsion; and
- 6. following the term of the expulsion, permit the students to be returned to regular school programs in Miami-Dade County Public Schools, if approved by School Operations.
