That impressive list includes Vitali Klitschko, Chris Byrd, Tony Tubbs, Larry Holmes, Mike Tyson, Michael Dokes, Frank Bruno, Bruce Seldon, Tim Witherspoon, Leon Spinks, James Bonecrusher Smith and Axel Schultz.

Mr. Ribalta started working as a school security monitor at Citrus Grove Elementary School in 1998. Then, he worked at Norland Middle School in 1999 and Robert Renick Education Center from 2000 to 2010. From 2010 to the present, Mr. Ribalta has worked as a full time security guard at Fienberg-Fisher K-8 Center. Currently, Mr. Ribalta lives in Miami Gardens and he works with people with autism.

The School Board appreciates the efforts of Jose Ribalta for keeping our schools safe. He is a Miami-Dade resident for nearly 40 years who has shown great commitment to the well-being of the students, parents, and families of Miami-Dade County Public Schools.

WHEREAS, Jose Ribalta's faced Mike Tyson in 1985 and lasted through 10 rounds, when Tyson was declared the winner by technical knockout; and

WHEREAS, Jose Ribalta's accomplishments include his first-round TKO win over former champion Leon Spinks at the Coconut Grove Exhibition Center in 1987; and

WHEREAS, Jose Ribalta currently works as a full-time security monitor at Fienberg-Fisher K-8 Center and has been with M-DCPS for the past 14 years as well as works with people with autism at a group home; and

WHEREAS, Jose Ribalta was recently inducted into the 2014 Florida Boxing Hall of Fame; and
