 2. review current local, state, and federal policies and protocols pertaining to immigration and law enforcement authorities on school grounds and District approved events to

ascertain what additional actions, if any, the District may advocate for at all levels of government to safeguard undocumented immigrant students' right to a free public education, including policy changes to be approved by the Board, and

3. continue to distribute guidelines to parents, students, and employees, by appropriate effective means of communication and include the following ten specific guarantees, as stated by the Superintendent: 1. All children/parents have the right to register and enroll independently of their immigration status, that includes undocumented children, no questions asked. 2. Neither undocumented students or their parents are required or requested to divulge their migratory legal status. It is not reflected on any document, it is not a question that is asked, it is not something that is recorded. 3. Schools cannot conduct an investigation that would expose in any way the legal status of students and their parents. So, should something happen in schools, specific to behavior, the child's immigration status is not something that would ever be included as part of any one investigation. 4. Students are not required to present a social security number to register in school or for any other reason. 5. Schools are not obligated to enforce immigration laws. 6. Our schools offer access to counselors for all students without regard to their immigration status and our schools provide them the same resources as any other student. 7. Undocumented students have the same right to transfer from one school to another as any other student without disclosing their immigration status. 8. Students are guaranteed the right to free or reduced lunch independent of their immigration status if they otherwise qualify. 9. Students have the same right to all services provided to all other students without regard to their legal status. 10. Law enforcement entities are prohibited access to our schools for the purpose of enforcing immigration laws without a valid court order, and they are not to be provided information without a lawfully issued subpoena. They must, absolutely, first contact our law enforcement agents prior to getting access to school. That extends beyond the school. If children are being transported to or from school on our school buses, they are protected, and

4. collaborate with community organizations on joint with common advocacy efforts goals, as detailed in this item.
