A Code of Student Conduct (COSC) Review Committee comprised of a diverse representation of committee members which encompassed representatives such as principals, district staff, community stakeholders, students, United Teachers of Dade, State Attorney's Office (SAO), Public Defender's Office, Department of Juvenile Justice, Miami-Dade County Juvenile Services Department, and Parent Teacher Student Association (PTSA) representatives, convened on several occasions to review and discuss recommendations for the revision of the Code of Student Conduct.

STUDENT CONDUCT AND DISCIPLINE

- Schools shall promote a positive school climate that supports academic achievement and emphasizes civility, fairness, mutual respect, and acceptance of diversity.
