Under Mayor Bermudez’s leadership, Doral, which is home to approximately 58,000 residents has become the premier place to Live, Work, Learn and Play. Since its incorporation in 2003, the city has received numerous national accolades, including being named the Best City for Business Start Ups by Business Week, #2 in America’s Top 25 Towns to Live Well, and #51 in the Top 100 Places to Live in the United States by CNNMoney.com. It was also named the fastest growing City in Florida and 11th in the country by the Florida International University’s Metropolitan Center.

The City of Doral is also home to five outstanding Miami-Dade County Public Schools. Mayor Bermudez has continuously made education in the city of Doral one of his priorities. In the past, under his direction and working with the Miami-Dade County School Board and local PTAs and PTOs, the City of Doral once became the only city in Miami-Dade County to have all of its public schools rated as “A” schools. The city currently hosts a variety of educational events throughout the year and has established a School Resource Unit as part of their Doral Police Department.

Mayor Bermudez graduated from the University of Miami with a Bachelor of the Arts degree and received his Juris Doctor degree from the University of Notre Dame Law School. He is currently a partner at Lubell Rosen, LLC in their Coral Gables office.
