This type of hearing loss is progressive, permanent, and typically painless so people often don't realize it's happening to them. Most important, NIHL is totally preventable, which is why Ear Peace Foundation is passionate about working with schools in Miami-Dade County.

In June, Ear Peace Foundation trained more than 500 teachers at the M-DCPS Summer Academy and anticipates that the teachers trained will be equipped to reach an additional 50,000 or more students during the 2018-2019 academic year.

Almost three times as many second graders are diagnosed with hearing loss compared to 10 years ago. Ear Peace Foundation provides teachers with information helpful in identifying at-risk children. With studies showing that 45 percent of musicians who participate in any type of musical group (orchestra, band, or choir) suffer permanent hearing loss by the age of 25, Ear Peace Foundation created a Protect-A-Band program that provides free filtered ear plugs to participating music teachers and their performing music students.
