Mrs. Patricia Parham devoted 43 years to Miami-Dade County Public Schools (M-DCPS), starting her career as a teacher and retiring as an Assistant Superintendent. Mrs. Parham was known for her impressive combination of positive energy, tireless dedication, and educational ability and expertise.

Mrs. Parham received a Bachelor of Science degree in Elementary and Early Childhood Education from Florida State University (FSU) and a Master of Science degree in Elementary/Secondary Supervision and Administration from Barry University. She began her teaching career in 1959 at Miami Park, then Carol City, Benjamin Franklin, Arcola Lake, Poinciana Park and Biscayne Gardens Elementary Schools.

Principal Parham led teachers, students and national partners to work unitedly and created a top-rated school, South Pointe Elementary. It was the first public/private school partnership in the nation. At Horace Mann Middle she oversaw the Computer Magnet School and at North Miami Elementary implemented School Based Management. As District Director of Early Childhood Programs her tenure encompassed the expanding knowledge of the importance of early intervention. She implemented new and creative programs, including the Executive Training Program, the first teacher pay-for-performance plan, and the recognition program for National Board Certified Teachers, as Assistant Superintendent of Human Resources and Development.

After retiring she consulted for Collier County and Detroit Public Schools, and Berkshire Advisors. She has received awards and honors most notably in 2001 FSU Outstanding Public Educator Award; FSU Outstanding Public School Administrator; Florida Commission of Education "Excellence in Leadership – Outstanding Principal's Award"; and profiled in a ten-part series by the Miami Herald "M-DCPS Teacher". She also chaired the South Florida Educational Federal Credit Union.

She has said that her proudest achievement is her family. The daughter of a teacher, Mrs. Parham passed on the love of education to her daughters Elizabeth and Penny. She has four grandchildren: Jack, Jamie, Jesse and Carrie, who is also following the family's footsteps in education.
