No one could argue the importance of teens learning how to drive especially today when teenagers face more distractions such as texting. At the September 5, 2018 School Board meeting, School Board Chair Perla Tabares Hantman introduced item H-9 which encouraged year-round safe driving practices. To best understand good driving skills, students should be introduced to the principles of good driving through driver education programming including behind-the-wheel training.

In 2002, the Florida Legislature created the Dori Slosberg Driver Education Safety Act (Florida Statute 318.1215), which authorized county commissioners to adopt a local option fee to be collected on all civil traffic fines. These funds from the fine were to be administered by the counties to fund driver education programs in public and non-public schools. The ordinance shall provide for the board of county commissioners to administer the funds, which shall be used for enhancement, and not replacement, of driver education program funds. The funds shall be used for direct educational expenses and shall not be used for administration. Each driver education program receiving funds pursuant to this section shall require that a minimum of 30 percent of a student's time in the program be behind-the-wheel training. The funds collected on all civil traffic fines related to the Dori Slosberg Driver Education Safety Act are placed by the County in the Driver Education Safety Trust Fund.

County commissioners reimburse Miami-Dade County Public Schools (MDCPS) via an interlocal agreement for the expenditures incurred related to its Drivers Education program. This interlocal agreement is the vehicle used by the County to disburse funds collected in the Driver Education Safety Trust Fund as a result of the Dori Slosberg Driver Education Safety Act. The County can only be reimbursed expenditures to the extent that there are funds in the trust fund. In 2014, MDCPS was reimbursed for the total costs incurred by its Drivers Education program during fiscal year 2012-2013 (i.e. \$3,170,463). Funding was granted to cover all costs associated with providing classroom and behind-the-wheel instruction to students at 37 public high schools throughout the County.
