In these audited financial statements the external auditor, RSM US LLP, concluded that, in their opinion, "...the financial statements...present fairly, in all material respects, the respective financial position...of The School Board of Miami-Dade County, Florida, as of June 30, 2018, and the respective changes in financial position, and, where applicable, cash flows thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America." This language constitutes an unmodified opinion, which is the highest opinion that can be assigned to a financial statement audit.

In conjunction with the yearly audit of the School Board's basic financial statements, RSM US LLP issued its Management Letter with an observation and corresponding recommendation related to review and approval controls over the Information Technology change management process. The Administration provided a response addressing this issue.

The School Board Audit and Budget Advisory Committee reviewed this report at its December 11, 2018, meeting and recommended its transmission to the School Board.
