Procurement Management Services, at the request of the Stores and Mail Distribution Warehouse, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract with firm, fixed prices, to purchase alcohol-based gel hand sanitizers for Miami-Dade County Public Schools (M-DCPS). This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with the District offices for additional community outreach, and its various media platforms, including but not limited to, social media, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for one (1) year, commencing January 13, 2021 through January 12, 2022, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidder, be extended for one (1) additional one (1) year period.

The Goal Setting Committee assigned an SBE/MBE sheltered market for this solicitation.

Nineteen (19) SBE/MBE certified vendors responded to this solicitation. Based on the criteria listed in the ITB and School Board Policy 6320, *Purchasing*, (X) Identical Prices/Tie Breakers, the contract shall be awarded to two (2) SBE/MBE certified vendors, one of which qualifies for local preference.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firms.
