**SUBJECT: AUTHORIZATION TO ACCEPT A DECLARATION OF RESTRICTIONS IN CONNECTION WITH APPLICATION NO. 03-162 F.V. CONSTRUCTION, CORPORATION, LOCATED AT THE SOUTHWEST CORNER OF S.W. 280 STREET AND S.W. 132 AVENUE, PROVIDING FOR A MONETARY DONATION IN ADDITION TO EDUCATIONAL FACILITIES IMPACT FEES AS ALLOWED FOR UNDER THE INTERLOCAL AGREEMENT**

**COMMITTEE: FACILITIES MANAGEMENT**

**Background**

F.V. Construction, Corporation, (applicant), is requesting a zoning change from AU (Agricultural) to RU-1M(a) (Modified Single Family), on 10 acres located at the southwest corner of S.W. 280 Street and S.W. 132 Avenue (see location map). The proposed additional 54-unit residential development is estimated to generate 45 students (see attached school impact analysis). The existing AU zoning presently allows the applicant to build 2 units.

Pursuant to the terms of the Interlocal Agreement for School Facility Planning (Interlocal), the School Board (Board), local government, in this instance Miami-Dade County (County), and the development community are to collaborate to develop options which seek to address the impact of proposed residential development on public schools where the development would result in an increase in the schools' FISH % utilization (permanent and relocatable), beyond the threshold review level of 115%. Please note that only one school facility impacted by the proposed development (senior high school) meets referenced threshold.

**Additional Information**

In connection with the rezoning request and to mitigate the impact of the proposed development on the public school system at the middle school level only, the applicant is voluntarily proffering a Declaration of Restrictions (Covenant) to the Board. Pursuant to the Covenant, the applicant will donate the amount of \$15,600, in addition to educational facilities impact fees estimated at \$137,088. The entire donation is due prior to final plat approval. In the event the County approves fewer units, the donation will remain the same.

The donation is to be utilized for capital improvements at the impacted school (Homestead Senior High School). To the extent that there are no pending or proposed capital improvements at the referenced school, the donation would be utilized for capital improvements at other schools within the affected feeder pattern.

The Covenant will be reviewed by the School Board Attorney's Office prior to recordation.

**RECOMMENDED:**

That The School Board of Miami-Dade County, Florida, authorize the Superintendent to accept a Declaration of Restrictions in connection with Miami-Dade County Application No. 03-162, F.V. Construction, Corporation, located at the southwest corner of S.W. 280 Street and S.W. 132 Avenue, for the provision of a voluntary monetary donation over and above educational facilities impact fees in the amount of \$15,600.

**OPERATING COSTS:** According to Financial Affairs, the average cost for K-12 grade students amounts to \$5,833 per student. The total annual operating cost for additional students residing in this development, if approved, would total \$262,485.

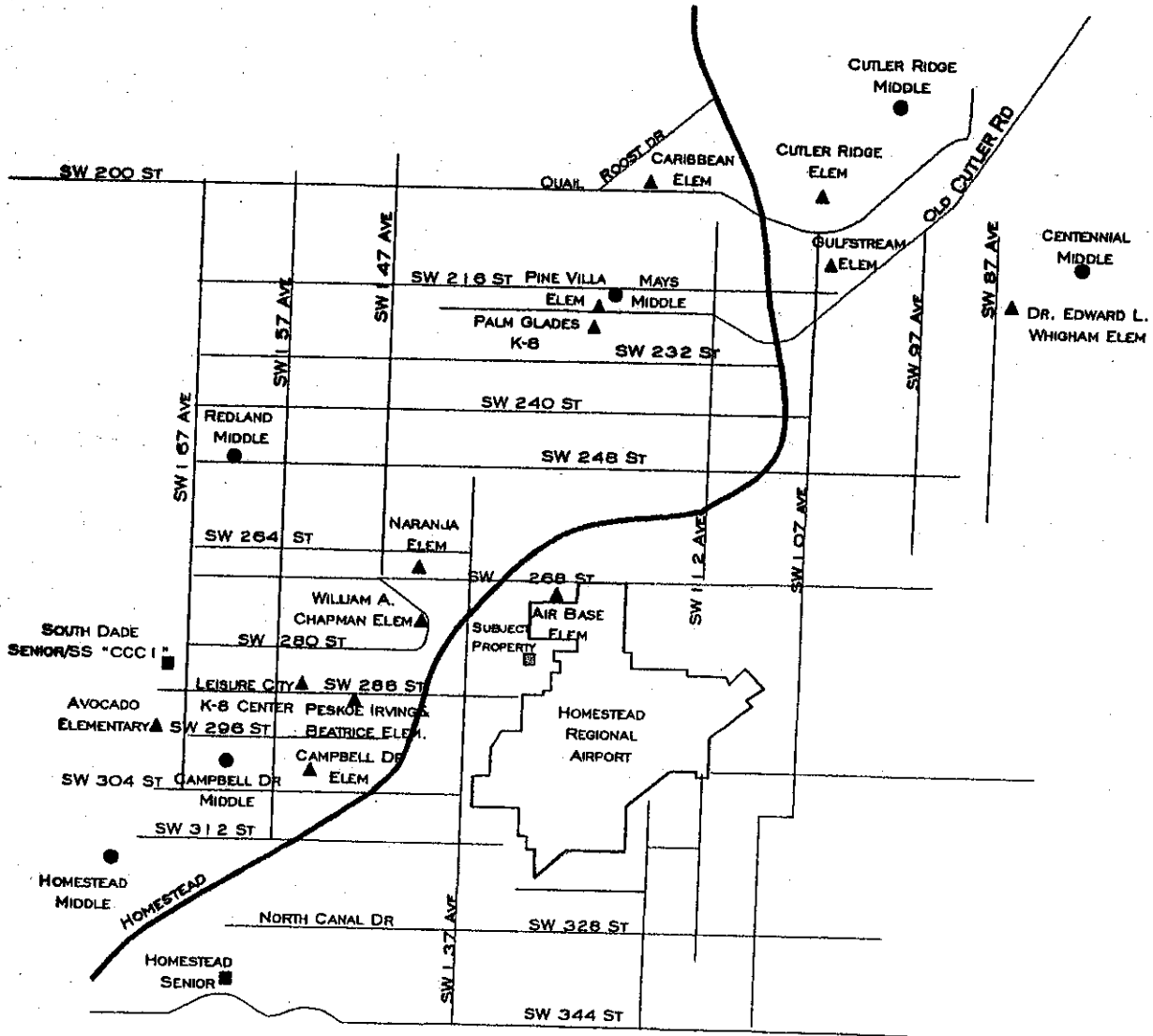
**CAPITAL COSTS:** Based on the State's October-2003 student station cost factors\*, capital costs for the estimated additional students to be generated by the proposed development are:

ELEMENTARY	21	x	\$ 13,294	=	\$ 279,174
MIDDLE	11	x	\$ 15,242	=	\$ 167,662
SENIOR	13	x	\$ 20,169	=	\$ 262,197

Total Potential Capital Cost \$ 709,033
