SUBJECT: RENEWAL OF BID #286-VV07 - TRANSPORTATION FOR SPECIAL **NEEDS STUDENTS**

The purpose of this bid, opened on June 11, 1998, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of transportation services for special needs students, for the Transportation Department. The terms of agreement, as contained in the subject bid, awarded by the Board on August 26, 1998, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew, for an additional one (1) year period, by letter, on file, with the exception of Health Trans, of North Miami, Florida who did not respond to the renewal request. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to provide continuity of service. The Bureau of Labor Statistics data shows that wages and salaries, including fringe benefits, have risen an average of 3.5%. The estimated dollar expenditure is based on the actual current number of students requiring this service, times the daily rate, times 180 school days, plus a 10% contingency.
