Description

This project is for the new construction of sixteen classrooms with support spaces and student and staff toilets. It also includes the structure reinforcement at the Mechanical Room, a new sprinkler system and various Safety-to-Life items.

This project is scheduled for substantial completion within 365 calendar days of the contract, or on July 14, 2000.

The Project Architect, M.C. Harry & Associates, recommended award of the contract to the low, responsive bidder, Crisal Construction Co., Inc.

Forty-four pre-qualified contractors were notified of this project and ten firms picked up plans and specifications.
