The purpose of this bid, opened on June 16, 1998, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of tree trimming and fence line clearing services, for the Bureau of Facilities Operations. The terms of agreement, as contained in the subject bid, awarded by the Board on August 26, 1998, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for one (1) additional one (1) year period, and, if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its initial year. The primary vendor, Florida Coast Services, Inc., has agreed to renew for a ninety (90) day renewal period, by letter, on file. The secondary vendor, Maria Del Caribe, Inc., elected not to renew. It is considered to be in the best interest of the Board to renew this bid, for an additional ninety (90) day renewal period, at the current prices, to provide continuity of service during this period. Staff is in the process of developing a new bid.
