SUBJECT: TERMINATE AND RE-AWARD OF BID #183-XX09 – PRINTING OF STUDENT CASE MANAGEMENT FORMS

This bid was awarded by the Board on April 14, 1999, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of student case management forms, for Stores and Mail Distribution stock.

Items 1 and 2 were awarded to Ciro B. Sosa, D/B/A Futura Advertising, of Coral Gables, Florida. Subsequent to the award, the awardee failed to perform in accordance with the terms and conditions of the bid. Based on the failure of this vendor to perform, it is recommended that the award of these items to Ciro B. Sosa, D/B/A Futura Advertising be terminated, and that the vendor lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08--Performance and Payment Security, Declining A Bid Award, And Bonding Company Qualifications. The items will be re-awarded to the second low bidder, Precept Business Products, Inc., of Miami, Florida.
