SUBJECT: AWARD OF BID #261-XX07 – DIESEL FUEL (LOW SULFUR) SOUTH OF FLAGLER STREET – TRANSPORT DELIVERY

The purpose of this bid, opened on June 8, 1999, is to establish a contract, to purchase, at a firm service charge, including escalation/de-escalation provisions for diesel prices and taxes, quantities, as may be required, of diesel fuel (low sulfur), for the Transportation Department. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 74 vendors sent bid forms or card notices of this advertised bid, 15 responded, with 10 bids meeting specifications and 5 no bids.
