The purpose of this bid, opened on November 18, 1999, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of pre-approved non-stock paint, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 114 vendors sent bid forms or card notices of this advertised bid, 18 responded, with 10 bids meeting specifications (includes 2 bids meeting individual item specifications, but not all item specifications; not all vendors bid all items), 1 non-responsive bid (vendor did not bid as specified) and 7 no bids.

Inasmuch as the only bid submitted for item 37 – architectural interior latex flat paint did not meet specifications, the recommendation reflects that the bid received be rejected. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Inasmuch as the only bid submitted for item 49A – architectural acrylic house paint did not meet specifications, the recommendation reflects that this item be rejected and that all bids received for item 49B – primer, and item 49C – masonry, be rejected, since these items can only be used with item 49A. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 – Bidding Process – Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
