**SUBJECT: AWARD OF BID #110-ZZ09 – PRINTING OF ORAL LANGUAGE
PROFICIENCY BOOKLETS**

The purpose of this bid, opened on December 7, 1999, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of printing of oral language proficiency booklets, for the Division of Bilingual/Foreign Language Skills and Exceptional Student Education. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 233 vendors sent bid forms or card notices of this advertised bid, 12 responded, with 3 bids meeting specifications, 1 non-responsive bid (bidder qualified bid with quantity requirements) and 8 no bids.

CDS Printing and Graphics, Inc., of Miami, Florida, made an error in pricing and has elected, by letter, on file, to lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 - - Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications.
