**SUBJECT: RENEWAL OF BID #141-XX07 - AUTOMOTIVE REPAIRS FOR SCHOOL BOARD VEHICLES**

The purpose of this bid, opened on December 19, 1998, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of automotive repairs, for School Board vehicles. The terms of agreement, as contained in the subject bid, awarded by the Board on February 10, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for three (3) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of Bayamo Paint and Body Shop, of Hialeah, Florida, Garcia Tire, Inc., of Miami, Florida, Metro Ford, of Miami, Florida, and Sun Chevrolet, of Miami, Florida. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, since the Consumer Price Index (CPI) indicates an increase of 4%.
