PROUD, an acronym which stands for Peacefully Resolving Our Unsettled Differences, is Miami-Dade County Public Schools' conflict resolution/peer mediation project. The goals of this important project include: establishing a peaceful school culture and environment; empowering students with skills for conflict resolution; teaching effective communications and problem solving skills; minimizing time taken from content instruction for student behavior and problems; and eliminating violence, managing anger, and reducing aggressive behavior. Program participants acquire a basic understanding of conflict and develop skills for peaceful resolution of it, build self-esteem, improve communication skills, and ultimately learn to recognize and respect the differences and similarities of others.

To honor outstanding achievers in peaceful conflict resolution, PROUD, in conjunction with the district's Advisory Committee on Multicultural Programs, sponsors the annual PROUD Peace Awards and ceremony. At the ceremony winners of the PROUD Peace School, PROUD Sponsor, and PROUD Peacemaker/Peer Mediator awards are honored. PROUD and its annual awards program offer great hope for our students to work out their conflicts peacefully and live in a nonviolent society. PROUD warrants Board and community support.
