SUBJECT: COMMISSIONING OF GILLER & GILLER, INC. TO PERFORM ARCHITECTURAL/ENGINEERING SERVICES FOR THE ADDITIONS, REMODELING AND RENOVATIONS PROJECT AT NORTH BEACH ELEMENTARY SCHOOL PROJECT #A-0775

Staff has completed the selection process for Project Architects to perform architectural/engineering services for two (2) additions, remodeling and renovations project at Biscayne Elementary and North Beach Elementary Schools.

Twenty-four (24) firms applied and ten (10) firms were interviewed by the A/E Service Committee. Of these ten (10) firms, two (2) were selected.

Giller & Giller, Inc.
Gili-McGraw Architects, Inc.

Negotiations with Giller & Giller, Inc. for North Beach Elementary School have been successfully completed.

The negotiated lump sum basic fee is \$313,799 with an estimated construction cost of \$4,163,758. This fee represents 7.54% of the construction cost. The multiplier for hourly compensation was limited to 2.45 for extra work. The lump sum fee also includes the following services 1) site sequence study, 2) record drawings update, 3) F.I.S.H. update, 4) special foundation design due to site conditions, 5) multiple phasing of construction process and 6) a construction period of at least 32 month duration. Additional lump sum fees were negotiated as follows: a)\$5,000 for a traffic engineering study; b) \$16,760 for reproduction of Board requested contract documents; c) \$2,000 for an acoustical consultant; d) \$5,000 for as-built documentation; e) \$10,600 for scope verification and engineering assessment report; f) at the Board's option the firm of Giller & Giller, Inc. will provide 175 site visits for a fee of \$35,925 for the duration of the construction process.

The Project Architect will maintain at least a \$1,000,000 project-specific Professional Liability Insurance policy, for which the A/E will be reimbursed up to a maximum of \$15,276.

The Principal/Owner for Giller & Giller, Inc. is Ira D. Giller.
