Seventeen (17) firms applied and eight (8) firms were interviewed by the A/E Service Committee for SPC-civil engineering services. Of these eight (8) firms, the following firms were selected:

Negotiations with AVART, Inc., have been successfully completed.

The negotiated agreement includes the following provisions for basic services:

A submittal fee of \$500.00 will be paid for each project that requires submission to the Office of Educational Facilities (OEF).

- 2. The agreement is for miscellaneous civil engineering projects with an initial estimated construction cost of \$200,000 or less. Projects that exceed this limit after the project has been initiated shall be negotiated on an individual basis.
- 3. The SPC will maintain at least a \$250,000 Professional Liability Insurance policy, with a deductible of \$15,000 per claim.

- 4. The term is for a two (2) year period commencing March 18, 2000 and expiring March 17, 2002.
- 5. The agreement provides for cancellation by the Board with or without cause, upon sixty (60) days written notice to SPC. The SPC may terminate this agreement, only with cause, upon sixty (60) days written notice to the Board.
- 6. The provisional multiplier for hourly compensation is limited to 2.45 for extra work.

The Principals/Owners for AVART, Inc., are Larry Lehman, George Starckey, William Schmitz and Hans Dierks.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida commission the firm of AVART, Inc., to provide Special Projects Consultant (SPC) services primarily civil engineering in nature, for the Board, during a period of two (2) years commencing March 18, 2000 through March 17, 2002.
