SUBJECT: AWARD OF BID #018-ZZ03 – FRESH DELIVERED SPECIALTY FOOD ITEMS, A LA CARTE

The purpose of this bid, opened on January 6, 2000, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of fresh delivered specialty foods, for use in the a la carte program at secondary schools only, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 205 vendors sent bid forms or card notices of this advertised bid, 12 responded, with 4 bids meeting specifications, (not all vendors bid all items), 1 non-responsive bid (vendor withdrew bid) and 7 no bids.

Inasmuch as the only bid submitted for item 4 was withdrawn, the recommendation reflects that the bid be rejected, to permit rebidding.

786 Pak Subway Enterprises, Inc., of Hialeah, Florida, made an error in pricing and has elected, by letter, on file, to lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 -- Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications.
