SUBJECT: BALANCE OF AWARD OF BID #075-ZZ05M/WBE – BALLASTS

The purpose of this bid, opened on December 2, 1999, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of ballasts, for Maintenance Materials Management stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. This bid is a Minority/Women Business Enterprise (M/WBE) set-aside for African American/Women-owned and operated businesses. Of 30 vendors sent bid forms or card notices of this advertised bid, 2 responded, with 2 regular bids.

Items 7 through 26, and 32 through 38 were awarded by the Board on February 9, 2000, for an estimated expenditure amount of \$101,703.94.

GROUP I: BALLASTS FOR HID LAMPS

- Item 1 - Ballast, HPS, multi tap, 120/208/240/277 volts, for 1-400 watt S-51 lamp @ \$55.06 each.
- Item 2 - Ballast, HPS, multi tap, 120/208/240/277 volts, for 1-250 watt S-50 lamp @ \$48.57 each.
- Item 3 - Ballast, HPS, 120 volts, for 1-100 watt S-54 lamp @ \$20.78 each.
- Item 4 - Ballast, HPS, multi tap, 120/208/240/277 volts, for 1-100 watt S-54 lamp @ \$30.12 each.
- Item 5 - Ballast, MV, multi tap, 120/208/240/277 volts, for 1-400 watt H-33 lamp @ \$30.23 each.
