**SUBJECT: RENEW BID #025-ZZ04 - SECURITY LOCKING DEVICES:

The purpose of this bid, opened on September 2, 1999, was to establish a contract, to provide and install, at firm educational discounts, quantities, as may be required, of security locking devices, for computers and various equipment. The terms of agreement, as contained in the subject bid, awarded by the Board on October 20, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed discounts during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of June 2000, indicated an increase of 3.7%.
