SUBJECT: APPROVE SUPPLEMENTAL AWARDS ON TERM BIDS

Bid #015-ZZ04 – COMPUTER PERIPHERAL PARTS AND SUPPLIES, CATALOG DISCOUNT, to establish a contract, to purchase, at firm educational discounts, quantities, as may be required, of computer peripherals parts and supplies, for various locations, during the term of the bid, effective October 20, 1999, through October 19, 2000. This supplemental award is requested due to higher than anticipated usage, resulting from various types of computer parts and supplies needed for repair and upgrades of existing equipment. This is a first time bid and no history of past purchases was available to determine more accurate estimated bid quantities. The monthly usage has averaged approximately \$316,182.12, due to the amount of aging equipment requiring replacement or repair, and equipment for new schools. The supplemental amount requested is based on the average monthly expenditure, times the twelve (12) month contract period, minus the original award amount, includes an additional ten (10) percent for the opening of new schools.
