SUBJECT: RENEW BID #003-XX03 – STORAGE AND DELIVERY OF FROZEN PIZZA AND PASTA PRODUCTS

The purpose of this bid, opened on June 11, 1998, was to establish a contract, for the storage and delivery of frozen pizza and pasta products, for the Food Service Program of the Department of Food and Nutrition. The terms of agreement, as contained in the subject bid, awarded by the Board on July 22, 1998, re-awarded on October 7, 1998, and renewed on June 23, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods and, if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its first renewal period. The awardees have agreed to renew for the final ninety (90) day renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional ninety (90) day renewal period, at the current prices, to benefit from fixed prices for the next ninety (90) days, inasmuch as the Consumer Price Index (CPI), as of May 2000, indicated an increase of 3.1% for all items and 6.2% for Transportation.
