**SUBJECT: AWARD BID #008-ZZ03 - MILKSHAKES, ICE CREAM, ICE MILK PRODUCTS AND FRUIT JUICE BARS**

The purpose of this bid, opened on September 14, 2000, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of milkshakes, ice cream, ice milk products and fruit juice bars, for use in the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 129 vendors sent bid forms or card notices of this advertised bid, 19 responded, with 4 bids meeting specifications (not all vendors bid all items), and 15 no bids.

Inasmuch as Item 24 - Cherry fruit pop, and Item 26 - Juice bar, with tube-shaped packaging, are alternates for other items being recommended for award, it is recommended that all bids received for these items be rejected.
