The contract is currently in its initial year. The awardee has agreed to renew for the final ninety (90) day renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional ninety (90) day renewal period, at the current prices, to benefit from fixed prices during the next ninety (90) days, inasmuch as the Consumer Price Index (CPI), as of October, 2000, indicated an increase of 3.4%. This ninety (90) day renewal is to provide continuity of service during this period.
