SUBJECT: AWARD BID NO. 104-AA07 – SEWING MACHINES AND CABINETS

The purpose of this bid, opened on February 22, 2001, is to establish a contract, to purchase, at firm unit prices and discounts, quantities, as may be required, of sewing machines and cabinets, for various schools and departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 50 vendors sent bid forms or card notices of this advertised bid, 17 responded, with 9 bids meeting specifications (includes 9 bids meeting individual item specifications, but not all item specifications; not all vendors bid all items) and 8 no bids.

Inasmuch as all bids submitted for Item 8 – Sewing machine, Item 9 – Sewing machine, Item 10 – Sewing machine, Item 11 – Sewing machine, Item 12 – Baby Lock, balance of line, Item 13 – Cabinet for Baby Lock sewing machine, Item 35 – sewing machine, industrial embroidery, Item 36 – SWF, balance of line, and Item 37 – One day training, did not meet specifications, the recommendation reflects that all bids be rejected to permit rebidding, using revised specifications.
