SUBJECT: TERMINATE BID NO. 020-ZZ09 – SHIRTS AND JACKETS, SCHOOL MONITOR

This bid was awarded by the Board on October 20, 1999, and renewed on October 20, 2000, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of school monitor shirts and jackets, for Stores and Mail Distribution stock.

Item 1 – Small shirt, Item 2 – Medium shirt, Item 3 – Large shirt, Item 4 – X-Large shirt, Item 5 – XX-Large shirt, Item 6 – XXX-Large shirt, Item 7 – Small jacket, Item 8 – Medium jacket, Item 9 – Large jacket, Item 10 – X-Large jacket, Item 11 – XX-Large jacket, and Item 12 – XXX-Large jacket, were awarded to School Daze Uniforms, Inc., of Miami, Florida. Subsequent to the award, the awardee failed to perform in accordance with the terms and conditions of the bid. Based on the failure of this vendor to perform, it is recommended that the award of these items be terminated and that the vendor lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 -- Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications. These items will be purchased, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 – Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
