SUBJECT: AWARD REQUEST FOR PROPOSALS NO. 154-AA10 – PRE-KINDERGARTEN EARLY INTERVENTION SERVICES FOR CHILDREN WHO MEET LEGISLATIVE ELIGIBILITY REQUIREMENTS FOR THE 2001 – 2002 SCHOOL YEAR

The purpose of this Request For Proposals, opened on June 12, 2001, is to establish a contract, to provide pre-kindergarten services, at firm prices, for approximately 2000 at-risk, four-year-old children who qualify for free lunch and have parent(s)/guardian(s) who are working and/or participating in the WAGES (Work and Gain Economic Sufficiency) Programs, for the Division of Early Childhood Programs. This is a term proposal which states that the Board may purchase quantities, as may be required, at the unit price proposed, but is not obligated to purchase any guaranteed amount. Of 50 vendors sent proposal forms or card notices of this advertised proposal, 9 responded, with 3 proposals meeting specifications, 1 proposal not meeting specifications and 5 no proposals.

Inasmuch as the proposals received did not meet the District's maximum requirement for pre-kindergarten services, an additional Request For Proposals will be issued in order to satisfy necessary requirements.
