SUBJECT: REQUEST FOR AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION FOR A COMMUNITY SERVICE GRANT FOR WLRN-FM; PROJECT CYCLE: JULY 1, 2001 THROUGH AUGUST 30, 2002

During the 2000-01 school year, the Florida Department of Education provided a Florida Community Service Grant, in the amount of \$110,662, to support programming and production on WLRN-FM. The School Board will be eligible for a Radio Community Service Grant in the amount of \$107,779 for the 2001-2002 school year.

The funds provided by this grant will be used to continue the employment of one program host/producer, one assistant producer/writer, and one associate producer/writer. Salary projections based upon current schedules indicate that the funds available in this grant will be less than the amount needed to maintain the current level of full-time staffing. Friends of WLRN, Inc., will provide the additional funds.

Official notification of this grant award was received on July 16, 2001, which is after the effective start date of the grant award. This grant award allows for the reimbursement of expenditures from July 1, 2001.

No local funds are required.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education, in the amount of \$107,779, for a Community Service Grant for WLRN-FM; Project Cycle: July 1, 2001 through August 30, 2002;
2. extend this grant award, at no additional cost, for up to one year, as authorized through official notification from the granting agency, if deemed necessary, in order to fully expend the grant award and thus complete the scope of the project; and
3. Financial Affairs to establish appropriations in the amounts approved by the granting agency; such appropriations to be reported periodically to the Board.
