SUBJECT: REQUEST FOR AUTHORIZATION FOR THE SUPERINTENDENT TO ISSUE A REQUEST FOR PROPOSALS FOR MENTAL HEALTH PROFESSIONALS/AGENCIES TO PROVIDE COUNSELING AND PSYCHIATRIC CONSULTATION SERVICES AT ROBERT RENICK EDUCATIONAL CENTER AND RUTH OWENS KRUSE EDUCATIONAL CENTER FOR EMOTIONALLY HANDICAPPED AND SEVERELY EMOTIONALLY DISTURBED STUDENTS, FROM JULY 1, 2002 THROUGH JUNE 30, 2003

Authorization is requested for the Superintendent to issue a Request for Proposals (RFP) for mental health agencies to provide counseling and psychiatric consultation services at Robert Renick Educational Center and Ruth Owens Kruse Educational Center for emotionally handicapped (EH) and severely emotionally disturbed (SED) students. Miami-Dade County Public Schools has been providing counseling and psychiatric consultation services to Robert Renick Educational Center and Ruth Owens Kruse Educational Center through professional services contracts since 1991. These services include individual, group, and family counseling as well as psychiatric consultation.

Consultant contracts for Robert Renick Educational Center and Ruth Owens Kruse Educational Center, in an amount not to exceed \$270,000, will be developed to provide services from July 1, 2002 through June 30, 2003. Pending funding availability, School Board approval will be requested to extend contracts which have been satisfactorily completed for up to two additional one-year-periods.

The selection of consultants will be made by a committee on the basis of several factors including qualifications, ability to provide bilingual services, and fee. The proposed members of the selection committee are:

- a region director for Exceptional Student Education or designee
- a supervisor for the Division of Exceptional Student Education
- a representative from Psychological Services
- a representative from the Superintendent's District Advisory Panel for ESE
- a representative from the Division of Business Development and Assistance
- a representative from the Bureau of Procurement and Materials Management
- a representative from each school receiving contracted counseling services
- a representative from United Teachers of Dade

The estimated timeline for implementation is as follows:

RECOMMENDED: That The School Board of Miami-Dade County, Florida:

- 1. authorize the Superintendent to issue a Request for Proposals to provide counseling and psychiatric consultation services at Robert Renick Educational Center and Ruth Owens Kruse Educational Center, for emotionally handicapped and severely emotionally disturbed students, in an amount not to exceed \$270,000, from July 1, 2002 through June 30, 2003; and
- 2. approve the selection committee to evaluate proposals submitted.
