SUBJECT: COMMISSIONING OF GILI-McGRAW ARCHITECTS, INC. TO REUSE ITS PROTOTYPE PRIMARY LEARNING CENTER (PLC) DESIGN FOR PLC "D-1" AT BRENTWOOD ELEMENTARY PROJECT# A-0785

The Planning Committee has assigned the firm of Gili-McGraw Architects, Inc. the reuse of its primary learning center (PLC) prototype design for PLC "D-1" at Brentwood Elementary School.

Negotiations with Gili-McGraw Architects, Inc. for the reuse of its PLC prototype design for PLC "D-1" at Brentwood Elementary School have been successfully completed.

The negotiated lump sum basic fee for PLC "D-1" at Brentwood Elementary School is \$195,650 with an estimated construction cost of \$2,776,923. This fee represents approximately 7.04% of the construction cost. The multiplier for hourly compensation was limited to 2.45 for extra work. An additional lump sum fee of \$18,000 was negotiated for reproduction of Board requested contract documents. At the Board's option, the A/E will provide 66 site visits for an additional fee of \$14,850 for the duration of the construction process.

The Project Architect will maintain at least a \$500,000 project-specific Professional Liability Insurance policy for each PLC project, for which the A/E will be reimbursed up to a maximum of \$18,000.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida commission the firm of Gili-McGraw Architects, Inc. for the reuse of its prototype PLC design for PLC "D-1" at Brentwood Elementary School for the following considerations:

- 1) lump sum basic fee of: \$195,650 for PLC "D-1" at Brentwood Elementary School, which represents approximately 7.04% of the construction cost;
- 2) at the Board's option, the A/E will provide 66 site visits for a fee of \$14,850, for the duration of the construction process;
- 3) the multiplier for hourly compensation was limited to 2.45 for extra work; and
- 4) the A/E will maintain at least a \$500,000 projectspecific Professional Liability Insurance policy, for which the A/E will be reimbursed up to maximum of \$18,000.
