SUBJECT: RENEW BID NO. 267-ZZ03 – BEVERAGES, CARBONATED

The purpose of this bid, opened on August 22, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of carbonated beverages, for the Department of Food and Nutrition a la carte program. The terms of agreement, as contained in the subject bid, awarded by the Board on October 11, 2000, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial fourteen (14) month period. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of Gilly Vending, Inc., of Aventura, Florida. It is considered to be in the best of interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, for food and beverages, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of December 2001, indicated an increase of 2.8%.
