Based on the failure of this vendor to pay access fees, it is recommended that the award of these items be terminated and that Nonstop Vending Corporation, of Miami, Florida, lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 - Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications.

Items 8, 12, 16, 24, 32, 48, 56, 60, 72, 80, 84, 88, 92, 96, 104, 136 and 140 shall be re-awarded to the second low bidder. Items 4, 20, 36, 40, 44, 52, 64, 68, 76, 100, 108, 112, 116, 120, 124, 128 and 132 are being rejected.

Efforts by staff to collect the fees were unsuccessful, therefore, this matter is being reviewed by the School Board Attorney to determine the course of action to be initiated to recover the access fees to the District.
