**SUBJECT: RENEW BID NO. 053-AA09 - MAINTENANCE SERVICE FOR
PRINTING EQUIPMENT**

The purpose of this bid, opened on January 9, 2001, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of maintenance service for printing equipment, for the Department of Graphics and Materials Production. The terms of agreement, as contained in the subject bid, awarded by the Board on March 14, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for one (1) additional one (1) year period. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of Spinola Printers Supply, of Sunrise, Florida, who chose not to renew Item 5 - Full maintenance service on Champion paper cutters. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of November 2001, indicated an increase of 1.9%.
